

CONSENT AGREEMENT BETWEEN THE COMPETITION COMMISSION, MURRAY & ROBERTS LIMITED AND FREYSSINET POSTEN PROPRIETARY LIMITED, IN RESPECT OF CONTRAVENTIONS OF SECTION 4(1)(b) OF THE COMPETITION ACT

## **PREAMBLE**

The Commission, Murray & Roberts and Freyssinet hereby agree that application be made to the Tribunal for the confirmation of this Consent Agreement as an order of the Tribunal in terms of section 49D as read with section 58(1)(b) of the Act, in respect of contraventions of section 4(1)(b)(i), 4(1)(b)(ii) and 4(1)(b)(iii) of the Act, on the terms below:



## DEFINITIONS

1

For the purposes of this Consent Agreement the following definitions shall apply:

- 1.1 "Act" means the Competition Act, 1998 (Act No. 89 of 1998), as amended;
- 1.2 "Commission" means the Competition Commission of South Africa, a statutory body established in terms of section 19 of the Act, with its principal place of business at 1st Floor, Mulayo Building (Block C), the dti Campus, 77 Meintijes Street, Sunnyside, Pretoria, Gauteng;
- 1.3 "Commissioner" means the Commissioner of the Competition

  Commission, appointed in terms of section 22 of the Act;
- 1.4 "Consent Agreement" means this agreement duly signed and concluded between the Commission, Murray & Roberts and Freyssinet;
- 1.5 "Cover Price" means, generally, a price that is provided by a firm that wishes to win a tender to a firm that does not wish to do so, in order that the firm that does not wish to win the tender may submit a higher price; or alternatively, a price that is provided by a firm that does not wish to win a tender to a firm that does wish to win that tender in order

that the firm that wishes to win the tender may submit a lower price;

"Freyssinet" means Freyssinet Posten Proprietary Limited a private company duly incorporated under the laws of the Republic of South Africa with its principal place of business at Unit 1 Poplar Place, 16B Axle Drive, Clayville, Olifantsfontein Gauteng. Until approximately November 2011, Freyssinet was a joint venture owned in equal parts by the Soletanche Freyssinet Group (based in France) and Murray & Roberts Steel Proprietary Limited, who was the managing partner of the joint venture. Freyssinet is currently wholly owned by the Soletanche Freyssinet Group;

- "Murray & Roberts" means Murray & Roberts Limited, a public company duly incorporated under the laws of the Republic of South Africa with its principal place of business at Douglas, Roberts Centre, 22 Skeen Boulevard, Bedfordview. Murray & Roberts offers civil, mechanical, electrical, mining and process engineering, general building, procurement, construction, commissioning, operations and maintenance services;
- 1.8 "Respondents" mean Murray & Roberts and Freyssinet;
- 1.9 "Tribunal" means the Competition Tribunal of South Africa, a statutory body established in terms of section 26 of the Act, with its

principal place of business at 3<sup>rd</sup> Floor, Mulayo building (Block C), the dti Campus, 77 Meintjies Street, Sunnyside, Pretoria, Gauteng.

#### 2 BACKGROUND

On 13 April 2010, the Commissioner initiated a complaint, in terms of section 49B(1) of the Act, against Amsteele Systems (Pty) Ltd ("Amsteele"), Tsala-RMS Construction Solutions (Pty) Ltd ("Tsala-RMS"), Freyssinet, Steelforce Systems (Pty) Ltd ("Steelforce") and the South African Post Tensioning Association ("SAPTA") in respect of their involvement in fixing prices and allocating tenders for the supply of post-tensioning steel in contravention of sections 4(1)(b).

#### 3 COMMISSION'S INVESTIGATION AND FINDINGS

3.1 Following its investigation, the Commission found that Freyssinet had, between the period June 2006 and December 2008, reached and implemented the following overarching arrangements:

Division of markets by allocating customers in contravention of section 4(1)(b)(ii) of the Act.

3.2 This overarching agreement was implemented by meetings and discussions between Freyssinet, Amsteele, Tsala-RMS to achieve an outcome of roughly equally shared available tenders for post-

## tensioning steel;

## Collusive tendering in contravention of section 4(1)(b)(iii) of the Act

- 3.3 This overarching agreement was implemented by:
- 3.3.1 participating in meetings and discussions between Freyssinet,

  Tsala-RMS and Amsteele wherein they identified and allocated tenders amongst each other for the provision of post-tensioning steel;
- 3.3.2 submitting cover pricing bids for each other's allocated projects; and
- 3.3.3 indirectly fixing prices by agreeing on controlled mark-ups and profit margins on tenders with a view to excluding substitutable products (in particular reinforcing steel bar).

## Price fixing in contravention of section 4(1)(b)(i)

- 3.4 Freyssinet indirectly agreed with competitors, Tsala-RMS, Amsteele and Steelforce, on industry trading terms and conditions in respect of applicable price adjustment formulae for post tensioning contracts.
- 3.5 This overarching agreement was reached by participating in meetings and discussions with competitors Amsteele, Tsala-RMS and

Steelforce, under the auspices of the SAPTA. The SAPTA members agreed upon and implemented an escalation formula and certain conditions of contract. The formula proportioned the mix of labour and materials applicable to the post tensioning industry and applied specific indices available from Statistics South Africa.

The Commission found that the above conduct contravened section 4(1)(b) of the Act

#### 4 ADMISSION

- 4.1 Murray & Roberts and Freyssinet admit that Freyssinet was involved in the collusive conduct detailed in paragraph 3 above with its competitors, in contravention of section 4(1)(b)(i), 4(1)(b)(ii) and 4(1)(b)(iii) of the Act.
- 4.2 Please see Annex "A", for a list of projects that, to the best of Freyssinet's knowledge, formed part of the above overarching collusive arrangements.

#### 5 COOPERATION

The Respondents, respectively, agree to fully cooperate with the Commission in its investigation and prosecution of the above conduct.

This cooperation includes, but is not limited to:

5.1.1 To the extent that it is in existence, provide evidence, written or otherwise, which is in their possession or under their control, concerning the alleged contraventions contained in this Consent

Agreement; and

5.1.2 To the extent that they are able, testify in the complaint referral in respect of the alleged contravention covered by this Consent Agreement.

## 6 FUTURE CONDUCT

6.1 Murray & Roberts and Freyssinet, respectively, agree and undertake to:

6.1.1 prepare and circulate a statement summarising the content of this agreement to their managers and directors within 14 (fourteen) days of the date of confirmation of this Consent Agreement as an order of the Tribunal;

6.1.2 refrain from engaging in collusive tendering in contravention of section 4(1)(b) of the Act, and from engaging in any prohibited practice under the Act in future;

6.1.3 If not already done so, the Respondents undertake to develop and implement a compliance programme designed to ensure that their employees, management and directors do not engage

in any conduct which constitutes a prohibited practice in terms of the Act, a copy of which shall be submitted to the Commission within ninety (90) days of the date of confirmation of this agreement as an order of the Tribunal; and

6.1.4 undertake henceforth to engage in competitive bidding.

#### 7 ADMINISTRATIVE PENALTY

- 7.1 Having regard to the provisions of sections 59(1)(a), 59(2) and 59(3) of the Act, the Respondents have agreed to pay the total settlement amount of R4 704 936 which amounts to approximately 7% of Freyssinet's turnover in 2011. This amount will be paid in the following manner:
- 7.1.1 Murray & Roberts agrees to pay an administrative penalty in the amount of R1 352 468 (one million, three hundred and fifty two thousand, four hundred and sixty eight Rand), which shall be paid by Murray & Roberts to the Commission on 31 August 2016 (accruing no interest).
- 7.1.2 Freyssinet agrees to pay an administrative penalty in the amount of R3 352 468 (three million, three hundred and fifty two thousand, four hundred and sixty eight Rand and nil cents) in two equal installments. The first payment, totaling R1 676 234

must be made to the Commission on 31 August 2016 and the second payment, totaling R1 676 234 must be made on 31 August 2017.

7.1.3

Freyssinet agrees to pay simple interest of 9.5% per annum on the second instalment of R1 676 234. This interest will be calculated and applied after one year from the date of the Tribunal's Order confirming this Consent Agreement.

7.1.4

Payment of the amounts referred to in paragraphs 7.1.1 and 7.1.2 above shall be made into the Commission's bank account, details of which are as follows:

7.2 The amounts referred to in paragraphs 7.1.1 and 7.1.2 above shall be paid over by the Commission to the National Revenue Fund in accordance with section 59(4) of the Act.
