All minutes and documents considered by the Third Respondent's Management Meetings, Board Meetings and Board Committee Meetings, including but not limited to Sales Meetings, held between 2001 to 2012 related to the pricing of power cables by the Third Respondent and the real cost to the Third Respondent in respect of power cables when sold in terms of long-term and short-term or tender contracts issued by various tender customers;

of Electric Cable Manufacturers Commercial sub-committee meetings, relating to the pricing and cost (including the cost of input materials) of power cables between 2001 and 2012;

- 6. All underlying documents or data submitted to the Commercial subcommittee of the Association of Electric Cable Manufacturers South Africa in
  respect of the basis for quotation of the raw material inputs as reflected in the
  minutes and circulars of the Association meetings, such as copper, lead,
  aluminium, SIMAG Redraw Rod, XLPE, steel tape, polyethylene and nonhalogenated compound, fully galvanised wire, SPVC cable compound, rubber,
  neoprene CR sheath, CM sheath, EPM insulation and silicone between 2001
  and 2012;
