ORDER

After having heard the parties' submissions in relation to the Applicant's application for suspension of the divestiture condition imposed by the Competition Commission in its approval of the merger between Kansai Paint co. Ltd and Freeeworld Coatings Limited on 18 April 2011 ("the divestiture condition"), the Tribunal hereby makes the following order:
